EDITORIAL

The aim of the IVIS international conference is to showcase technical and scientific innovations in the field of the VIP (Vacuum Insulation Panel).

In 2017 it will be open to aerogel and porous silica type Innovative Porous Materials.

This scientific conference will bring together industrial and professional stakeholders from the thermal insulation sector and researchers, who will present, comment on and discuss the results of their recent work.

The IVIS international conference has been held every two years since 2005 in different countries: Switzerland, Germany, United Kingdom, Canada, and China.

The thirteenth session of the IVIS international conference will take place on 20 and 21 September, 2017 in Paris.

Organised by CSTB, it will cover all the following themes:

1. Characterisation (microstructure, thermal characteristics, internal pressure, air permeability, gas diffusion, adsorption, etc.)
2. Combined heat, air and humidity transfers; from the material to the building
3. Ageing (film, raw material, panel)
4. Envelope - Films
5. Innovative Porous Materials - Core Materials (Fibrous Mats, Cellular Foams, Aerogel, Porous silica, etc.)
6. Life-cycle analysis, Incorporated Energy
7. Applications: Construction, Refrigeration, Transport
8. Performance Evaluation and Standardisation

In addition to auditorium presentations, poster sessions and the presence of industrial exhibitors are also planned.

CSTB also plans to organise a technical tour of its laboratories, followed by workshops on Wednesday 19 September to encourage discussions and the exchange of ideas under Appendix 65 of the IEA:
